TRADEMARK ASSIGNMENT

Recitals

WHEREAS, Assignor was the owner of all right, title and interest in the trademark LANE SEVEN registered with the United States Patent and Trademark Office, Reg. No. 4538544, for "men's clothing, namely, tee shirts, sweatshirts, jeans, pants, sweaters, woven shirts and shorts" (hereinafter the "Mark"); and

WHEREAS, Assignee desired to and did acquire, and Assignor did contribute and assign to Assignee, all right, title and interest in and to the Mark and the registration therefor, together with the goodwill of the business represented and symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby acknowledge and ratify the conveyance, assignment and delivery of the Mark to Assignee, and Assignor otherwise sells, assigns, and transfers to Assignee, its successors and assigns, and Assignee accepts, all of Assignor's right, title and interest in and to the Marks in any and all forms in which they have been used and including any and all common law rights therein, and including the trademark registration listed above, and any other trademark registrations and applications for the Mark, together with the goodwill of the business connected with the use of and symbolized by the Mark being assigned, and all causes of action for any and all past infringements of the rights being assigned and the right to retain the proceeds therefrom.

This Assignment is effective *Nunc Pro Tunc* as of January 22, 2014.


