Corporation Law of the State of Delaware (the "DGCL")

PAE SMART INVESTMENTS, INC., a corporation organized and existing under and by virtue of the laws of the State of Delaware (the "Corporation"), hereby certifies as follows:

1. That by unanimous written consent of the Board of Directors in lieu of a special meeting of the Board of Directors of the Corporation, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and referring said amendment to the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Corporation be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

"**FIRST**: The name of the corporation is Saber Interactive Inc. (the "Corporation")."

2. That thereafter, pursuant to resolution of its Board of Directors, the holders of all of the outstanding stock of the Corporation duly approved and adopted said amendment by written consent in lieu of a special meeting in accordance with Section 228 of the DGCL.
