- 1.2 **Further Assurances:** shall sign, execute and do all deeds, schedules, acts, documents and things as may be reasonably required by the Assignee to effectively carry out and give effect to the terms and intentions of this Deed including but not limited to perfecting the Assignee's title in the Trade Mark and the Application.

This Deed is governed by the laws of New Zealand and each party submits to the exclusive jurisdiction of the New Zealand courts.


