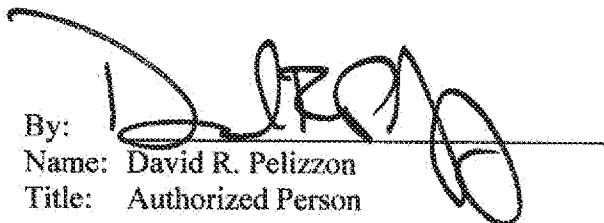
**FIRST:** The name of the limited liability company is Squadron Newco LLC (the "Company").
