TRADEMARK ASSIGNMENT AGREEMENT

U.S. Registration No. 3193475 for SHOP FOR YOUR HOME FROM YOUR HOME


WHEREAS, Assignee desires to acquire exclusive rights in and to the Marks and all associated goodwill in said Marks;

1. Assignment. Assignor hereby irrevocably assigns and transfers to Assignee its successors and assigns all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, along with the registrations thereof, the numbers of which are contained herein.
2. Recordal. Assignor hereby authorizes Assignee's representatives to execute the necessary applications, registrations and proprietorship forms for recordal with the respective worldwide trademark offices.
3. Authority. The parties hereto represent and warrant that they have full power and authority to execute, deliver and perform this Agreement and such other instruments as required herein and to consummate the transactions contemplated hereby.
4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Pennsylvania (regardless of the laws that might otherwise govern under applicable Pennsylvania conflict of laws principles).

IN WITNESS WHEREFORE, the Assignor, by and through its authorized representative, does hereby acknowledge that it has read, understands and consents to the terms, conditions, and obligations contained herein and executes the same in his/her representative capacity.
