Ladies and Gentlemen:

You have requested The CIT Group/Business Credit, Inc. to accept from Wells Fargo Business Credit, Inc. ("New Lender"), payment in full of all indebtedness and liabilities of Precept Medical Products, Inc. (the "Borrower"), owing as of November 15, 2002 (the "Payoff Date"), and to terminate our financing arrangement with and security interests in the collateral of the Borrower.

will satisfy in full all of the indebtedness and liabilities to us of the Borrower. Upon wiring such sum to us and our receipt of a copy of this letter executed by the Borrower and New Lender, our security interests and liens in the Borrower's assets shall automatically terminate and you will be authorized to terminate all financing statements filed by us against the Borrower, including, without limitation, the financing statements listed on the attached exhibit. In addition, if it is

determined that we have any other security interests in or liens on any property of the Borrower securing the retired indebtedness, we will execute such documents as you may reasonably request to release such security interests and liens.

In consideration of the foregoing, by its signature below, the Borrower hereby releases CIT from and with respect to all actions, claims, damages and demands which the Borrower has or could assert against CIT under, in connection with, or in any manner related to, the financing arrangement between the Borrower and CIT referenced in this letter, except in respect of CIT's obligation to deliver UCC-3 termination statements and releases of collateral in accordance with the terms of this letter.

The Borrower and New Lender acknowledge that CIT may not yet have received full and final credit for all checks or similar instruments for the payment of money heretofore delivered to CIT by the Borrower or its customers pursuant to the provisions of our financing arrangement with the Borrower and deposited by CIT for collection, the amount of which checks and similar instruments have nevertheless been credited to the Borrower in the computation of the Payoff Amount. Accordingly, the Borrower and New Lender, jointly and severally, agree to reimburse and pay CIT, or cause CIT to be reimbursed or paid promptly upon CIT's demand, the full face amount of any such checks or similar instruments heretofore delivered to CIT by the Borrower or its customers, in the event that such checks or instruments are dishonored or returned unpaid to CIT for any reason whatsoever, within thirty (30) days from the date hereof.
