RELEASE OF TRADEMARK SECURITY INTERESTS

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement, dated as of March 10, 2015 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office (the "PTO") at Reel 5500, Frame 0548 on April 20, 2015, Mindcrest Inc., an Illinois corporation, ("Grantor"), granted to ACF FINCO I LP (the "Lender"), a continuing security interest in certain Trademarks (as defined in the Trademark Security Agreement), including those trademarks listed on Exhibit A attached hereto (the "Trademark Collateral"), as collateral security for the payment and performance of the Obligations pursuant to that certain Loan and Security Agreement, dated as of March 10, 2015 (the "Loan Agreement").

WHEREAS, Grantor has requested, and Lender has agreed, to provide a document suitable for recording in the PTO for purposes of evidencing the release, relinquishment, discharge and termination of Lender's security interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined, herein have the respective meanings given to them in the Trademark Security Agreement or the Loan Agreement.
2. Release of Security Interest. The Lender hereby releases, relinquishes, discharges and terminates its security interest in the Trademark Collateral and assigns any and all such right, title and interest that the Lender may have in the Trademark Collateral to Grantor.
3. Further Assurances. The Lender, at Grantor's expense, shall execute and deliver to Grantor such further documents as Grantor may reasonably request to further confirm this release of security interest in the Trademark Collateral in the PTO or as otherwise reasonably required.
