## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 30th day of April, 2020, by WELLS FARGO CAPITAL FINANCE, LLC, as Administrative Agent and Collateral Agent ("Agent"), in favor of AMERICAN COMMERCIAL BARGE LINE LLC, a Delaware limited liability company, formerly known as American Commercial Lines LLC, OLD JB LLC, a Delaware limited liability company, formerly known as Jeffboat LLC, and COMMERCIAL BARGE LINE HOLDINGS LLC, a Delaware limited liability company, formerly known as Commercial Barge Line Company (each a "Grantor", and collectively, the "Grantors").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby agrees as follows:

1. Release. Agent hereby releases all liens and security interests granted by the Grantors in favor of Agent pursuant to that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of November 12, 2015, executed by the Grantors in favor of Agent and recorded with the United States Patent and Trademark Office on November 16, 2015 at Reel 5668, Frame 0957, including without limitation all liens and security interests in the trademarks listed on Schedule A attached hereto.

2. Termination. Agent terminates and cancels the Trademark Security Agreement.


3. Further Assurances. Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.





