**FIRST AMENDMENT TO GRANT OF SECURITY INTEREST IN UNITED STATES
TRADEMARKS**

This First Amendment to Grant of Security Interest in United States Trademarks, dated as of May 1, 2020 (this "Amendment"), by and between HANNA ANDERSSON, LLC, a Delaware limited liability company ("Grantor"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Collateral Agent for its own benefit and the benefit of the Lenders ("Grantee"). Unless otherwise defined herein, all capitalized terms used herein which are not defined shall have the meanings given to such terms in the Trademark Security Agreement (as defined below).

WHEREAS, Grantor and Grantee are parties to the Grant of Security Interest in United States Trademarks, dated September 26, 2016 (as amended hereby and as the same may hereafter be further amended, modified, supplemented, extended, renewed, restated or replaced, the "Trademark Security Agreement") and recorded with the Assignment Division of the United States Patent and Trademark Office on September 26, 2016 at Reel/Frame 5883/0990;

WHEREAS, since the date of Grantor's execution of the Trademark Security Agreement, Grantor has acquired interests in additional Trademarks (the "New Trademarks"); and

WHEREAS, in accordance with the Security Agreement, the parties agree to amend the Trademark Security Agreement to confirm the inclusion of such New Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Amendment to the Trademark Security Agreement. The Trademark Security Agreement is amended as follows:

(a) Schedule A to the Trademark Security Agreement shall be amended by adding the items set forth on Exhibit A hereto to Schedule A to the Trademark Security Agreement.

2. Miscellaneous.

(a) Captions. Section captions used in this Amendment are for convenience only, and shall not affect the construction of this Amendment.

(b) Counterparts. This Amendment may be executed in any number of counterparts and by the different parties on separate counterparts, and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same Amendment.

(c) Intercreditor Agreement. This Amendment is subject to the terms and conditions set forth in the Intercreditor Agreement (as defined in the Security Agreement) in all respects and, in the event of any conflict between the terms of the Intercreditor Agreement and this Amendment, the terms of the Intercreditor Agreement shall govern.
