**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This RELEASE OF TRADEMARK SECURITY AGREEMENT is made this 30th day of April, 2020, by The Provident Bank (the "Secured Party") in favor of A.P. Deauville, LLC (the "Grantor");

**WITNESSETH**

WHEREAS, on December 30, 2009, the Secured Party (referred to therein as "Bank") and the Grantor (referred to therein as "Borrower") executed a Trademark Security Agreement (the "Security Agreement"), which was recorded on February 3, 2010 at Reel 4142, Frame 0842, in the United States Patent and Trademark Office, pursuant to which the Grantor granted the Secured Party a lien in and security interest upon certain trademarks of the Grantor as more particularly described in Exhibit A attached hereto (the "Trademarks"); and

WHEREAS, the indebtedness secured by the Security Agreement (and Loan and Security Agreement executed contemporaneously therewith) has been paid and satisfied in full and the Secured Party, at the request of the Grantor, has agreed to release and terminate its lien in and security interest upon the Trademarks;

NOW THEREFORE, for and in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the Secured Party hereby releases, discharges and terminates its lien in and security interest upon the Trademarks, and transfers and conveys to the Grantor all of the Secured Party's right, title and interest in the Trademarks and the goodwill associated therewith.

This Release of Trademark Security Agreement shall be binding upon the Secured Party and its successors and assigns.
