INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), effective December 31, 2019 (the "Effective Date"), is made and entered into by and between Mitsubishi Chemical Media Co., Ltd., a Japanese *kaishu* corporation and a wholly-owned subsidiary of MCC ("MCM" or the "Assignor") and CMC Magnetics Corporation, a Taiwanese corporation ("Assignee") (each a "Party," and collectively, the "Parties"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement (defined below).

WHEREAS, the Parties and Mitsubishi Chemical Corporation, entered into a Master Purchase Agreement, dated as of June 14, 2019 (the "Purchase Agreement"), pursuant to which, among other things, Assignor has agreed to sell, transfer and assign to Assignee and Assignee has agreed to purchase and accept the transfer and assignment of all right, title and interest in and to the assets described herein from Assignor;

WHEREAS, Assignor is the owner of each of the patents and patent applications set forth corresponding to its name on Schedule A hereto (the "Patents"), and the owner of each of the trademark and service mark registrations and applications (including any and all goodwill symbolized by any of the foregoing) set forth corresponding to its name on Schedule B hereto (the "Trademarks") and certain Copyrights exclusively used by the Business (the Patents, Trademarks and Copyrights, collectively, the "Assigned IP"); and

WHEREAS, pursuant to the Purchase Agreement, the Parties are obligated to execute and deliver this Assignment upon the Closing.

NOW THEREFORE, for good and valuable consideration, including the premises and covenants set forth in the Purchase Agreement and herein, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment. Effective upon the Closing, Assignor hereby assigns and transfers to Assignee, and Assignee hereby accepts the assignment and transfer of, all right, title and interest in and to the Assigned IP, including all rights therein provided by international conventions and treaties, all rights of priority and renewals, all rights claiming or covering the Assigned IP, all rights and causes of action that may have accrued to the Assignor to sue and recover damages for past, present and future infringement, dilution, misappropriation, unlawful imitation or other violation thereof or conflict therewith. Parties agree that Schedule A and Schedule B attached hereto collectively shall supersede and replace in its entirety Section 2.1(d) of the Seller Disclosure Schedules to the Purchase Agreement. For the avoidance of doubt, upon the completion of the registration of transfer as required in this Assignment, Assignor will have no responsibility to take any action to maintain any of the Assigned IP or further prosecute or seek issuance of any applications included in the Assigned IP, including payment of fees, responses to any office action or other inquiries from agents of governmental entities or registrars, or otherwise.



2. Due Authorization. Assignor hereby authorizes and requests the Commissioner of Patents of the United States Patent and Trademark Office, the Commissioner of Trademarks of the United States Patent and Trademark Office and any other official of any applicable Governmental Body to record this Assignment and to issue any and all registrations from any and all applications for registration included in the Assigned IP to and in the name of Assignee.

3. Further Assurance. Assignor further agrees to execute any and all papers and documents, and take such other actions as are reasonably requested by the Assignee, to evidence and perfect the foregoing assignment, and to fully cooperate in any application for registration of the assignment of all Assigned IP.

4. Governing Law. This Assignment shall be interpreted, construed and governed by and in accordance with the Laws of the State of New York without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction) that would cause the application of the Law of any jurisdiction other than those of the State of New York. The dispute resolution/jurisdiction clauses in the Purchase Agreement shall apply to this Agreement.

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original and all of which, when taken together, shall be deemed to be one and the same agreement or document. A signed copy of this Assignment transmitted by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Assignment for all purposes.

6. Conflict. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of Assignee or Assignors under the Purchase Agreement, except that Schedule A and Schedule B attached hereto collectively shall supersede and replace in its entirety Section 2.1(d) of the Seller Disclosure Schedule to the Purchase Agreement as set forth in Section 1 hereof. The Parties agree that the rights and remedies of the Parties in respect of the transactions contemplated herein are more fully set forth in the Purchase Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

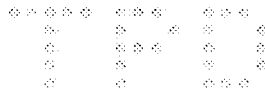
