NOW, THEREFORE, based on the foregoing premises and the consideration set forth in the APA, Assignor hereby conveys, transfers, assigns, and delivers to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Marks and the herein identified registrations of the Marks and all renewals thereof, together with the goodwill associated with the Marks and the business symbolized by the Marks and registrations thereof; and all rights, interests, claims, remedies, demands, and damages, recoverable in law or in equity, that Assignor has or may have for past, ongoing, current, and/or future infringements of or other violations of rights in the Marks, including without limitation the rights to compromise and/or to sue for and/or collect said damages. All of the foregoing shall be held and enjoyed by Assignee, for its own benefit and for the benefit of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks, including any actions necessary for maintaining or obtaining trademark registrations thereof, and for the recordal of this Assignment with the U.S. Patent & Trademark Office .

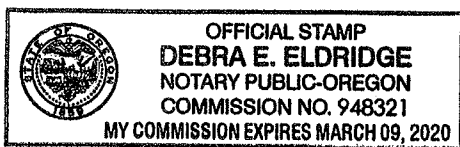
