FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This First Supplement to Trademark Security Agreement (this “*First Supplement*”) is made as of May 4, 2020 by and between **SAVE MART SUPERMARKETS**, a California corporation (the “*Grantor*”) and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as agent for itself and certain other credit parties (the “*Grantee*”).

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated June 18, 2015 and recorded on June 19, 2015 at Reel 5556, Frame 0893 (as amended of record from time to time hereinafter, the “*Agreement*”) in favor of the Grantee, pursuant to which the Grantor pledged, assigned and granted a security interest in certain trademarks and trademark applications (the “*Marks*”); and

WHEREAS, Grantor developed additional Marks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of Assignee; and

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
2. Supplement to Schedule A. Schedule A to the Agreement is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This First Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
