## TRADemark ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this "Assignment") is made and entered into as of May 5, 2020 ("Effective Date"), by and between Travelport, LP, a Delaware limited partnership ("Assignee"), and Travelport Inc., a Delaware corporation and indirect parent entity of Assignee ("Assignor").

**WHEREAS**, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's right, title and interest in and to the registered trademarks set forth on Schedule A attached hereto (the "Trademarks").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Trademarks, for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with (i) any and all claims and causes of action, whether accruing before, on or after the Effective Date, and the right to seek damages for the past, present or future infringement, misappropriation, dilution, or other violation of the Trademarks, (ii) all rights to proceeds, income, revenues and royalties, whether accruing before, on or after the Effective Date with respect to the Trademarks and (iii) the goodwill of Assignor's business associated with the Trademarks.

1. Assignor authorizes and requests the United States Commissioner of Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of all right, title and interest in and to the Trademarks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

2. Each of Assignor and Assignee agrees that for all U.S. federal and state income tax purposes, the Assignment will be treated as a transfer of the Trademarks via the following steps: (i) a contribution of the Trademarks by Assignor to Worldspan Technologies Inc., a Delaware corporation ("WTI"), followed by (ii) a contribution of the Trademarks by WTI to Travelport Holdings LLC, a Delaware limited liability company ("THLLC"), followed by (iii) a contribution of the equivalent of 0.004% of the Trademarks by THLLC to Worldspan LLC, a Delaware limited liability company ("Worldspan"), followed by (iv) a contribution of the equivalent of 99.996% of the Trademarks by THLLC to Assignee, and followed by (v) a contribution of the equivalent of 0.004% of the Trademarks by Worldspan to Assignee.

3. Assignor shall take all further actions, and provide Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation), reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment.

4. This Assignment may be signed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
