

be held and enjoyed by the Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by the Assignor had this Assignment not been made.

Nothing herein shall be construed as an assignment or transfer of any right, title and/or interest in and to the Rock Creek trademark as used by Assignor, its affiliates and/or related entities on products, or any corresponding registration(s) therefore.
