**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 23, 2020, is executed by JPMORGAN CHASE BANK, N.A., as administrative agent under the Credit Agreement (as defined below) (in such capacity, “JPM”), in favor of KLO ACQUISITION, LLC, a Delaware limited liability company (together with its affiliates, “KLO”).

**WITNESSETH:**

**WHEREAS**, KLO has executed that certain Pledge and Security Agreement, dated as of December 30, 2016 (as amended, restated, supplemented, or otherwise modified from time to time, the “Security Agreement”; capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement) in favor of JPM for the benefit of the lenders (collectively, the “Lenders”) under that certain Amended and Restated Credit Agreement, dated as of April 7, 2017 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”);

**WHEREAS**, in accordance with the Security Agreement, KLO has executed that certain Notice of Grant of Security Interest in Trademarks recorded with the United States Patent and Trademark Office on January 5, 2017, as Reel/Frame 5955/0932 (collectively, the “Trademark Security Agreement”),

**WHEREAS**, pursuant to the Trademark Security Agreement, KLO pledged and granted to JPM a security interest in the trademarks that are the subject of the applicable registration and serial/application numbers listed on Exhibit A hereto (such trademarks, collectively the “Marks”);

**WHEREAS**, on February 11, 2020, KLO entered into that certain Asset Purchase Agreement, pursuant to which KLO sold, among other things, the Marks to 185 West Main Financial, LLC (the “KLO Asset Sale”); and

**WHEREAS**, on February 11, 2020, KLO and Agent entered into that certain Consent Under Amended and Restated Credit Agreement, pursuant to which Agent consented to the KLO Asset Sale.

**NOW, THEREFORE**, in consideration of the foregoing, JPM, acting for and on behalf of, and in its capacity as agent for, the Lenders, hereby releases its liens on and security interest in the Marks. Except as expressly amended by this Release, the terms of the Trademark Security Agreement shall remain in full force and effect as executed.
