1. I am the CEO of Matchless Candle Co., a California corporation, ("Registrant") and I am authorized to execute this declaration on behalf of Matchless Candle Co.

2. I am the President of Shenzhen Liown Electronics Co., Ltd., a corporation of China ("Shenzhen Liown Electronics") and I am authorized to execute this declaration on behalf of Shenzhen Liown Electronics Co., Ltd.

3. In my positions with Registrant and Shenzhen Liown Electronics, I am familiar with the organizations' corporate structures.

4. Matchless Candle Co. is organized as a corporation under the laws of the State of California and is still an active California corporation.

5. Shenzhen Liown Electronics Co., Ltd. is organized as a corporation under the laws of China and is still an active corporation of China.

6. In the document filed at Reel 5772, Frame 0589, Registrant's entity designation was inadvertently listed as a California "company" rather than as a California "corporation." Similarly, Shenzhen Liown Electronics was inadvertently listed as a "company" of China, rather than as a "corporation" of China.

7. The use of "company" instead of "corporation" was made in good faith.

8. At the time of the Trademark Assignment, the correct entity designation for Registrant was as a California corporation and the correct entity designation for Shenzhen Liown Electronics was as a corporation of China.

9. This declaration is made in support of the corresponding Corrective Assignment filed to correct the good faith use of "company" instead of "corporation" made in the Cover Sheet and Trademark Assignment recorded at Reel 5772, Frame 0589.

10. All statements in this declaration made of my own knowledge are true; and all statements in this declaration made on information and belief are believed to be true in support of Registrant's Corrective Assignment.
