## TRADEMARK AND DOMAIN ASSIGNMENT CONFIRMATION

1. Assignment. Assignor hereby confirms that it has sold, transferred, conveyed, assigned and delivered to Assignee all of its right, title and interest in and to the Trademark and the goodwill associated with such Trademark free and clear of all liens by virtue of the Assignment Agreement. Assignee hereby confirms that it has accepted the assignment of the Trademark by virtue of the Assignment Agreement. Assignor further confirms that from and after the date of the Assignment Agreement, Assignee has become the exclusive owner of all of Assignor's right, title and interest in and to the Trademark. Assignee confirms that Assignee is currently still the legitimate owner of the Trademark.

2. Use of this Confirmation. The parties agree that this Confirmation may be filed by Assignee to the relevant and competent trademark offices (USPTO, EUIPO, etc.) in order to register Assignee as sole and new holder of the Trademark in the corresponding register/domain authority and to fully delete Assignor as holder. The Assignor declares his irrevocable and unconditional consent to this register this change of ownership.


