**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is dated as of May 7, 2020, by TRUIST BANK (successor by merger to SunTrust Bank), as Administrative Agent (the "Secured Party") to LTS SOFTWARE LLC (formerly LTS Software, Inc.) (the "Debtor").

**RECITALS**

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of April 30, 2012 (the "Security Agreement") executed by the Debtor in favor of the Secured Party and recorded in the United States Patent and Trademark Office (the "USPTO") on August 21, 2018, at Reel 006426 / Frame 0497, the Debtor granted to the Secured Party a security interest in the Debtor's right, title and interest in and to the United States trademarks set forth on Schedule 1 attached hereto and made a part hereof (the "Trademark Collateral").

WHEREAS, the indebtedness and obligations secured by the Security Agreement have been paid and satisfied in full, and the Debtor has requested that the Secured Party release any and all right, title and interest it may have in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party agrees, for the benefit of the Debtor, as follows:

**RELEASE**

The Secured Party hereby terminates the Security Agreement and terminates, releases, relinquishes and discharges its security interest in, lien on and right of set-off against all of the Debtor's right, title and interest in, to and under the Trademark Collateral and all right, title and interest of the Debtor in the Trademark Collateral are hereby reassigned by the Secured Party to the Debtor (without recourse, representation or warranty).


The Secured Party authorizes the Debtor to record this Release with the USPTO and/or otherwise record or file this Release in any applicable governmental office or agency.

The Secured Party further agrees to execute and deliver to the Debtor any additional documentation necessary to effect the release of the security interest of the Secured Party in the Trademark Collateral (without recourse, representation or warranty and at the Debtor's sole cost and expense).
