NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is entered into effective nunc pro tunc as of February 26, 1999 by and between American Promotional Events, Inc. – East, formerly known as American Promotional Events of Alabama, Inc. (an Alabama Corporation) ("Assignor") and American Promotional Events, Inc. (an Alabama Corporation) ("Assignee").

WHEREAS, Assignor's predecessor in interest and affiliated company, China Pyrotechnics, Inc. Corporation, assigned its rights in the trademark registration(s) identified in Exhibit A, incorporated herein by reference (the "Trademarks") and all goodwill associated therewith, to Assignor on January 1, 1995, under Assignor's then name, "American Promotional Events, Inc." (an Alabama corporation) ("Alabama I");

WHEREAS, Assignor (Alabama I) changed its name from "American Promotional Events, Inc." (an Alabama corporation) to "American Promotional Events of Alabama, Inc." (an Alabama corporation) as of December 31, 1998;

WHEREAS, Assignor (Alabama I) was known as "American Promotional Events of Alabama, Inc." (an Alabama corporation) from December 31, 1998 until March 26, 2002, at which time it changed its name to "American Promotional Events, Inc.–East" (an Alabama corporation);

WHEREAS, Assignor (Alabama I) changed its name from "American Promotional Events of Alabama, Inc." (an Alabama corporation) to "American Promotional Events, Inc. – East" (an Alabama corporation) as of March 26, 2002;



WHEREAS, Assignor's affiliated company, American Promotional Events, Inc. (an Alabama corporation) was also previously also known as American Promotional Events of Alabama, Inc. (an Alabama corporation) ("Alabama II") from September 24, 1997 until October 5, 1998, and ultimately changed its name to "American Promotional Events, Inc." (an Alabama corporation) as of February 26, 1999; and


WHEREAS, Assignor and all of said affiliated companies intended that American Promotional Events, Inc., (Alabama II) be the owner of the Trademarks and goodwill associated therewith; and

WHEREAS, Assignor ("Alabama I") desires to transfer nunc pro tunc its right, title and interest in and to the Trademarks, together with the goodwill associated therewith to Assignee ("Alabama II").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers and assigns nunc pro tunc as of February 26, 1999, to Assignee its right, title and interest in and to the Trademarks, together with the goodwill associated therewith, including all registrations and applications thereto, as well as all renewals and extensions of registrations thereof, including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Trademarks, with the right to sue for damages and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.
