**NOTICE OF PARTIAL RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Partial Release”) is made as of May 8, 2020, by ALLY BANK, as Revolving Collateral Agent (together with its successors and assigns in such capacity, “Agent”), in favor of CHAMPION BUS, INC. and ELDORADO NATIONAL (KANSAS), INC. (together with their predecessors in interest with respect to the Released Trademarks (as defined below), successors and assigns, each, a “Grantor” and, collectively, the “Grantors”).

Agent reserves to itself, as agent for itself and the various lenders, the security interest previously granted to Agent by Grantors in all other Trademarks listed on Schedule I to the Grant.


Agent hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Partial Release.
