## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (“Assignment”) is made effective as of March 10, 2020 (the “Effective Date”) by and between:

Cubic Motion Limited (“Assignor”), a private limited company organized under the laws of the United Kingdom with an address at 3<sup>rd</sup> Floor, Bright Building Manchester Science Park, 5 Pencroft Way, Manchester, England, M15 6GZ;

and

Epic Games, Inc. (“Assignee”), a corporation organized under the laws of the U.S. State of Maryland with an address at 620 Crossroads Boulevard, Cary, North Carolina 27518 USA.

**WHEREAS**, under the terms of that certain Deed of Assignment dated March 10, 2020 (the “Agreement”), Assignor conveyed, transferred, and assigned to Assignee, among other assets, certain intellectual property of Assignor, and agreed to execute and deliver this Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in all applicable jurisdictions;

**WHEREAS**, subsequent to the execution of the aforementioned Deed of Assignment, Cubic Motion Limited changed its name to Epic Games Animation UK Ltd. (with the same registration number); and


**WHEREAS**, Assignor and Assignee wish to memorialize the assignment that took place on March 10, 2020 for the purposes of recordation.

1. Assignment. 2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in all applicable jurisdictions to record and register this Assignment upon request by Assignee.
3. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


