RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is dated May 12, 2020, by Keybank National Association, as lender ("*Secured Party*").

WITNESSETH:

WHEREAS, Secured Party and North American Logistics Group LLC ("*Grantor*"), are parties to a certain Trademark Security Agreement dated as of February 20, 2018 ("*Trademark Security Agreement*"), which was recorded in the United States Patent and Trademark Office on February 21, 2018, at Reel 6276, Frame 0803, pursuant to which the Grantor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Grantor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in, and reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to the Trademark Collateral, as defined in the Trademark Security Agreement, including, inter alia:

(i) Each of the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by, each of such Trademarks; and

(ii) All proceeds of the foregoing, including without limitation any claim by Grantor against third parties for damages by reason of past, present or future infringement of any of the Trademarks or by reason of injury to the goodwill associated with any of such Trademarks, in each case together with the right to sue for and collect said damages.
