TRADEMARK ASSIGNMENT

Assignor undertakes that upon the request of Assignee or its designees, it and/or its successor in business, shall make all rightful oaths, testify on behalf of Assignee or its designees in matters involving the Mark and do all other lawful acts necessary to carry out the intent of this Trademark Assignment as well as to provide such other material, information and assistance to Assignee or its designees, as may be considered necessary in connection therewith.




