TRADEMARK ASSIGNMENT

WHEREAS, RICHLINE GROUP, INC., a corporation organized under the laws of the State of Delaware with offices at 1385 Broadway New York, New York United States 10018 ("ASSIGNOR") is owner of the following (collectively, the "Trademark Rights"):

The U.S. Trademark Registration No. 5147298 for RAVEL ROSE, registered on Feb. 21, 2017 ("RAVEL ROSE" trademark); and

Any and all rights and privileges provided under RAVEL ROSE trademark, unfair competition and other laws of the United States, the individual states thereof and jurisdictions foreign thereto with respect to the mark of the foregoing registrations; the GOODWILL of the business in which the mark is used; and any and all renewals thereof, together with the right to bring suit and collect for past infringements thereof.

WHEREAS, Nigel Woolley, a United Kingdom individual with offices at Witnors, Wiltshire Road Braceborough Lincolnshire United Kingdom PE94NX ("ASSIGNEE"), acquired the Trademark Rights.

NOW, THEREFORE, for good and other legally sufficient and valuable consideration in the amount of \$2500 (two thousand five hundred US Dollars) to be paid by ASSIGNEE to ASSIGNOR within 5 (five) business days of the Effective date of this Agreement and sufficiency of which are hereby acknowledged, ASSIGNOR HEREBY on the Effective date of this Agreement assigns and transfers to ASSIGNEE all right, title and interest in and to the Trademark Rights including, without limitation, the GOODWILL of the business in which the mark is used and the rights to assert such registered trademark and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.


ASSIGNEE shall, without further consideration, execute any additional documents and

The Effective Date of this Agreement is April 30, 2020


