TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** ("Assignment") is entered into and effective as of the date of the last signature below, by and between GILBERT COOPER and DEBBIE COOPER, United States individuals with an address of 10416 Francis Road, Winchester, Ohio 45697 ("Assignors"), and SMOKY MOUNTAIN KNIFE WORKS, INC., a Tennessee corporation with an address of 2320 Winfield Dunn Parkway, Sevierville, Tennessee 37876 ("Assignee") (each a "Party" and collectively the "Parties").

WHEREAS, Daniels Family Cutlery Corporation, doing business from time to time as Queen Cutlery Company, and Queen Cutlery Company (hereinafter collectively "Daniels Family Cutlery") had adopted and used and were the owners of the trademarks set forth on the accompanying Schedule A and the registrations therefor and the goodwill of the business associated therewith (the "Trademarks");

WHEREAS, on or about August 15, 2019, pursuant to a UCC Article 9 auction, Daniels Family Cutlery auctioned off, sold, and assigned the Trademarks and the goodwill of the business associated therewith to Assignors;

WHEREAS, Assignors had purchased the Trademarks in trust for Assignee; and

WHEREAS, the Parties wish to ratify and confirm the transfer of the ownership of the Trademarks and associated goodwill of the business from Assignors to Assignee in a document suitable for recordation at the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the sum of \$28,000.00 paid by Assignee to Assignors, the mutual covenants and promises set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Parties hereby **AGREE** as follows:

1. Assignors do hereby assign, sell, and transfer to Assignee, its successors and assigns, all right, title and interest in and to the Trademarks, together with the goodwill of the business associated with and symbolized by the Trademarks, and the registrations therefor.
2. Assignors further agree, without any additional consideration, to execute and deliver all documents reasonably necessary to effectuate recordation of this assignment with the United States Patent and Trademark Office, and consent to the recordation of the subject assignment reflecting transfer of ownership of the Trademarks.
3. This Agreement may be executed in any number of separate counterparts, but all such counterparts (including facsimiles and PDFs) shall together be deemed to be an original of a single instrument.
