## PARTIAL RELEASE OF TRADEMARK

THIS PARTIAL RELEASE OF TRADEMARK dated May 14, 2020, by Bank of Montreal, in its capacity as administrative agent (“*Administrative Agent*”) for the Secured Creditors (as such term is defined in the Security Agreement referred to in Trademark Agreement).

### WITNESSETH:

WHEREAS, Administrative Agent and IntegraMed America, Inc., a Delaware corporation (“*Debtor*”) are parties to that certain Trademark Collateral Agreement dated December 17, 2015, which was recorded in the United States Patent and Trademark Office (“*USPTO*”) on December 18, 2015 at Reel 5692, Frame 0972 (the “*Trademark Agreement*”), pursuant to which Debtor granted a security interest in certain trademarks, trademark registrations, and trademark applications listed on Schedule A attached thereto and certain other property, among other things, as security for the Secured Obligations as referred to in the Trademark Agreement; and

WHEREAS, the Debtor has requested that the Administrative Agent (i) release its security interest in such trademark named “ARTWORKS” under registration number 2389563 registered on September 26, 2000 (the “*ARTWORKS Trademark*”), and (ii) reassign any and all right, title and interest of the Administrative Agent, if any, in and to the ARTWORKS Trademark to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby releases its security interest in all of its right, title and interest, if any, in and to the ARTWORKS Trademark, and the goodwill of the business associated with such trademark.

*It is expressly understood and agreed that this a Partial Release of Trademark is in no way to operate to discharge the lien of any other trademark, trademark registration, or trademark application set forth in the Trademark Agreement, or any supplements or amendments thereto, but it is only to release the trademark particularly described herein and none other; and that the remaining or unreleased trademarks, trademark registrations, and trademark applications described in the Trademark Agreement, or in any supplements or amendments thereto, shall remain as security for the payment and performance of the Secured Obligations.*
