ASSIGNMENT

This ASSIGNMENT is made as of the 13th day of May, 2020 (the "Effective Date") by and between United States Soccer Federation, Inc., a New York corporation with its principal place of business at 1801 S. Assignor does hereby sell, assign, and transfer to Assignee all of Assignor's worldwide rights, title and interest in and to the trademarks U.S. SOCCER FOUNDATION and US SOCCER FOUNDATION, and any logos bearing those marks (collectively, the "Foundation Marks"), including all international, federal, state and common law rights for the Foundation Marks and all accompanying goodwill associated therewith, including the right to recover damages and profits for past, present or future infringements or other unauthorized uses of the Foundation Marks.

2. Assignor does hereby sell, assign, and transfer to Assignee all of Assignor's rights, title and interest in and to United States Trademark Registration Nos. 2,327,950; 2,235,888; 2,702,781; and 2,702,785, and U.S. Trademark Serial No. 87/495,842 for the Foundation Marks, and all accompanying goodwill associated therewith.

3. Assignor shall promptly execute all documents, papers, forms and authorizations (including electronic) and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title and interest in the Foundation Marks, including all federal, state and common law rights, and including the filing of such documents, papers, forms and authorizations (including electronic) with the United States Patent and Trademark Office to record the assignment of the Foundation Marks to Assignee.

4. This Assignment shall be binding upon Assignor, Assignee, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
