DEED OF ASSIGNMENT
OF INTELLECTUAL PROPERTY

THIS DEED OF ASSIGNMENT is made on 11 APRIL

2019

BETWEEN:

- (1) **L.K. BENNETT LIMITED (IN ADMINISTRATION)** (company number 02699136) whose registered office is at Rivington House, 82 Great Eastern Street, London, EC2A 3JF ("Company");
- (2) **ROBERT HUNTER KELLY** of Ernst & Young LLP, 1 Bridgewater Place, Water Lane, Leeds LS11 5QR, **DANIEL CHRISTOPHER HURD** of Ernst & Young LLP, 1 Colmore Square, Birmingham B4 6HQ and **CRAIG ANTHONY LEWIS** of Ernst & Young LLP, 1 More London Place, London SE1 2AF ("Administrators"); and
- (3) **BYLAND UK LIMITED** (company number 11903831) whose registered office is at St Ann's Wharf, 112 Quayside, Newcastle Upon Tyne, United Kingdom, NE1 3DX ("Assignee").

BACKGROUND:

- A The Administrators were appointed joint administrators of the Company on 7 March 2019 by the sole director of the Company pursuant to paragraph 22 of schedule B1 to the Insolvency Act 1986.
- B The Company owns the various intellectual property rights referred to in this deed.
- C Pursuant to the terms of the Sale Agreement (as defined below) the Company has agreed to sell to the Assignee such right title and interest as it holds in (inter alia) the Assigned Rights (as defined below).
- D The Company has agreed to enter into this deed at the request of the Assignee to perfect the transfer to the Assignee of the Company's right, title and interest in the Assigned Rights.

IT IS AGREED:

1. DEFINITIONS

- 1.1 In this deed, unless the context otherwise requires, the following words and expressions have the following meanings:

"Administrators' Solicitors" means DLA Piper UK LLP, Princes Exchange Princes Square, Leeds LS1 4BY;

"Assigned Rights" means any Intellectual Property Rights owned by or registered to the Company, including (but not limited to) the Trade Marks and the Domain Names;

"Bank" means Wells Fargo Capital Finance (UK) Limited;

"Domain Names" means the domain names, short particulars of which are set out in part 2 of schedule of this deed;

"Intellectual Property Rights" means patents, rights to inventions, copyright and related rights, trade marks and service marks, trade names and domain names, rights in get-up, rights to goodwill and to sue for passing off and unfair competition, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how and trade secrets) and any other intellectual property rights, in each case whether registered or

unregistered and including all applications (and rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist, now or in the future, in any part of the world;

"Sale Agreement" means the business and asset sale agreement dated on or around the date of this Deed and made between, amongst others, the parties to this deed;

"Trade Marks" means the registered trade marks, short particulars of which are set out in part I of schedule of this deed;

"TOGC" means the transfer of a business or part of a business as a going concern for the purposes of section 49 of the Value Added Tax Act 1994 and article 5 of the Value Added Tax (Special Provisions) Order 1995; and

"VAT" means value added tax imposed in any member state of the European Union pursuant to Council Directive (EWC) 2006/112 on the common system of value added tax and national legislation implementing that Directive or any predecessor to it, or supplemental to that Directive, or any similar tax which may be substituted for or levied in addition to it or any value added, sales, turnover or similar tax imposed in any country that is not a member of the European Union.

1.2 In this deed (unless the context requires otherwise) any reference to:

- (a) any gender includes all genders, any reference to the singular includes the plural (and vice versa), and references to person includes bodies corporate, unincorporated associations and partnerships (whether or not any of them have a separate legal personality);
- (b) legislation or a legislative provision includes reference to the legislation or legislative provision as amended or re-enacted from time to time (whether before or after the date of this deed) and any prior or subsequent subordinate legislation made under it which is in force from time to time (except to the extent that any amendment, re-enactment or subordinate legislation made after the date of this deed would increase or extend the liability of any party under this deed);
- (c) statutory obligations includes obligations arising under Articles of the Treaty establishing the European Community and regulations and directives of the European Union as well as UK Acts of Parliament and subordinate legislation;
- (d) obligations undertaken by a party which comprise more than one person shall be deemed to be made by them jointly and severally;
- (e) a clause or schedule is to a clause of or schedule to this deed, any reference to a part or paragraph is to a part of paragraph of a schedule to this deed, any reference within a schedule to a part is to a part of that schedule, and any reference within a part of a schedule to a paragraph is to a paragraph of that part of that schedule;
- (f) any professional firm or company includes any firm or company effectively succeeding to the whole, or substantially the whole, of its practice or business;
- (g) the contents list, headings and any descriptive notes are for ease of reference only and shall not affect the construction or interpretation of this deed;
- (h) "including", "includes" or "in particular" means including, includes or in particular without limitation; and

- (i) the Administrators shall be construed as being the Administrators both jointly and severally and to any other person who is appointed as an administrator in substitution for any administrator or as an additional administrator in conjunction with the Administrators.

1.3 The Interpretation Act 1978 shall apply to this deed as it does to an Act of Parliament.

1.4 Except as expressly set out in this deed, any lists contained in any schedule or annexure are for guidance only and are not exhaustive or complete lists of the items in question and shall not constitute any warranty in respect of the Company's ownership of the listed items or otherwise.

1.5 This deed incorporates the schedules and any appendices to it.

1.6 Clause and Schedule headings shall not affect the interpretation of this deed.

2. ASSIGNMENT

Pursuant to and for the consideration set out in the Sale Agreement, the Company hereby assigns to the Assignee all its rights, title and interest (if any) in and to the Assigned Rights, including the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership or registration of, or title to any of the Assigned Rights occurring after the date of this deed.

3. VAT

3.1 All payments made by the Assignee under this deed are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Company, the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply, provided that the Company shall have delivered a valid VAT invoice in respect of such VAT to the Assignee.

3.2 The parties believe that the sale of the assets of the Company under the Sale Agreement will be a TOGC and they shall use their reasonable endeavours to procure that the sale is treated as such. This obligation shall not require the Company to make any appeal against any determination of Her Majesty's Revenue and Customs that the sale does not amount to a TOGC.

4. LIABILITY

4.1 The Assignee acknowledges that no warranty is given in respect of the Assigned Rights. The Assignee acknowledges that in respect of the Assigned Rights the Administrators' knowledge is limited and that accordingly the Company is selling only such title as it may have to the Assigned Rights. If the Company does not have title or unencumbered title to the Assigned Rights the Assignee hereby expressly agrees that it shall have no right to rescind this Assignment nor to any damages or a reduction in the consideration paid or payable pursuant to the Sale Agreement.

4.2 No warranty, condition or assurance is given or implied whether statutory or otherwise as the nature of the Assigned Rights and neither the Company nor the Administrators shall be liable for any loss, damage, expense or damage of any kind whatsoever of any sort in any of the Assigned Rights.

4.3 The Assignee hereby acknowledges that it accepts that the terms and conditions herein are reasonable in the context of a sale by an administrator in accordance with the provisions of the Unfair Contract Terms Act 1977 having regard to the fact that:

- (a) this is a sale by a company in administration in circumstances where it is usual that no representations, warranties and conditions express or implied, statutory or otherwise are given by or on behalf of the Company, or the Administrators (or any of them); and
- (b) the Company and the Administrators have informed the Assignee that the Assignee must rely absolutely on the Assignee's own opinion and/or professional advice concerning the Assigned Rights, their condition and nature, the possibility that some or all of them may have defects not apparent on due diligence, the reason the Assignee has or should have for purchasing the same and the use of which it intends or should intend to put them.

5. LIMITATIONS OF LIABILITY

- 5.1 The parties acknowledge that in the negotiation, execution and performance of this deed, the Administrators, are acting only as agents for the Company. Neither the Administrators, nor the Administrators' firm nor any of the Administrators' partners, employees, agents or advisers shall have any personal liability of any kind under or in connection with this deed or under any document executed pursuant to this deed or in respect of any claim relating to this deed or any such document.
- 5.2 The limitations of liability in this deed shall also apply to any document executed pursuant to this deed and shall arise and continue notwithstanding the termination of the Administrators' appointment after the signing of this deed, and shall operate as waivers of any claims in tort as well as under the law of contract.
- 5.3 This deed is intended to take effect as a deed notwithstanding that it has been signed by the Administrators under hand only.

6. FURTHER ASSURANCE

- 6.1 The Company (acting by the Administrators) agrees that it shall, so far as it is reasonably able and only for the period which the Administrators remain in office after and notwithstanding completion of this deed (at the Assignee's expense and for such time as the Administrators remain in office) execute and deliver all further documents, required by law or which the Assignee reasonably requests, to vest in the Assignee the full benefit of the right, title and interest in the Assigned Rights as assigned to the Assignee under this deed, including:
 - (a) registration of the Assignee as applicant or (as applicable) proprietor of the Assigned Rights; and
 - (b) assisting the Assignee in obtaining, defending and enforcing the Assigned Rights, and assisting with any other proceedings which may be brought by or against the Assignee against or by any third party relating to the Assigned Rights.
- 6.2 The terms of all such documents referred to in clause 6.1 above shall be subject to the prior approval of the Administrators' Solicitors.

7. **COUNTERPARTS**

This deed may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original of this deed, but all the counterparts shall together constitute the same deed.

8. **ASSIGNMENT AND SUCCESSORS**

8.1 Neither party may assign, transfer, declare any trust over or deal in any way with its rights under this deed without the prior written consent of the other party.

8.2 This deed shall be binding on and continue for the benefit of the successors and assignees of each party.

9. **THIRD PARTY RIGHTS**

No person other than a party to this deed shall have any rights to enforce any term of this deed.

10. **GOVERNING LAW AND JURISDICTION**

10.1 This deed and any matter arising from or in connection with it shall be governed by and construed in accordance with English law.

10.2 Each party irrevocably agrees to submit to the exclusive jurisdiction of the English courts over any claim or matter arising from or in connection with this deed or the legal relationships established by or in connection with this deed.
