This DEED is dated:

March 22 2020

**PARTIES:**

- 1) **WARGAMING WORLD LIMITED**, a company incorporated in the Republic of Cyprus (registered number HE 317029) whose registered office is at 105 Agion Omologiton, Agiol Omologites, 1080, Nicosia, Cyprus (*Wargaming World*), and
- 2) **WARGAMING.NET LIMITED**, a company incorporated in the Republic of Cyprus (registered number HE 340231) whose registered office is at 105 Agion Omologiton, Agiol Omologites, 1080, Nicosia, Cyprus (*Wargaming.Net*),  
(each a party, and together, the parties).

**RECITALS:**

- A. By a court order dated 4 March 2020, the District Court of Nicosia approved a scheme of arrangement dated 7 October 2019 that was submitted to it by Wargaming World and Wargaming.Net (*Court Order*).
- B. Pursuant to the Court Order, there will be a restructuring of the parties through the merger of Wargaming World and Wargaming.Net, with Wargaming.Net being the surviving entity of the merger, under which the Wargaming.Net Trade Marks and Wargaming.Net Domain Names (as defined below) shall be assigned and transferred to Wargaming.Net.
- C. As the Wargaming.Net Trade Marks are subject to the laws of a number of jurisdictions around the world, the parties have been advised by their professional advisors to enter into this Deed to ensure that full effect is given to the Court Order and, in particular, to ensure that the Wargaming.Net Trade Marks shall be assigned in all the jurisdictions around the world in which they are registered and to provide full documentary evidence of such assignment.
- D. Accordingly, this Deed has been entered into by the parties in the context of the aforementioned scheme of arrangement and pursuant to the Court Order.

**AGREED TERMS:**

1. Definitions and interpretation

1.1 In this Deed the following capitalized words and expressions shall have the following meanings:

*Court Order* has the meaning given to it in Recital (A).

*Deed* means this deed of assignment, including the Recitals.

*Effective Date* means 1 April 2020.

*Encumbrance* means any interest or equity of any person (including any right to acquire, option or right of pre-emption) or any mortgage, charge, pledge, lien, assignment,





hypothecation, security interest, title retention or any other security agreement or arrangement.

**Intellectual Property Rights** means:

- (a) rights to inventions, patents, plant variety rights or plant breeders' rights, and utility models, including any supplementary protection certificates or other extensions of any of the foregoing,
- (b) copyrights, neighbouring and related rights, and all rights in the nature of copyright including economic rights, authors' rights, moral rights and rights in the nature of moral rights and *droits moraux*, copyright in software, copyright in databases, rights of communication to the public (including by way of cable, satellite, internet broadcasting or otherwise), rental and lending rights, rights to issue copies to the public, public performance rights and "making available" rights,
- (c) trade marks and service marks, trade names, business names, corporate names and commercial signs, titles to works, geographical indications, registered designations of origin, traditional specialities guaranteed, rights in domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off and/or unfair competition,
- (d) rights in designs, industrial designs and industrial property, design patents, rights in aesthetic and functional designs, and topography of semiconductor products,
- (e) rights in computer software and rights in the nature of computer software,
- (f) rights in computer game, television and film formats, rules, functions and game mechanics,
- (g) rights in databases and rights in the nature of database rights,
- (h) rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets and traditional knowledge), and
- (i) all other Intellectual property rights,

in each case whether in whole or in part, whether registered or unregistered and for the whole legal term of protection of such rights and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection that subsist or will subsist, now or in the future, in any jurisdiction in any part of the world.

**Wargaming.Net Domain Names** means the internet domain names set out with short particulars in Schedule 2 to this Deed.

**Wargaming.Net Trade Marks** means:

- (a) the registered trade marks and pending applications for registered trade marks set out with short particulars in Part A of Schedule 1 to this Deed; and
- (b) the trade marks, words and devices (whether registered or unregistered) set out with short particulars in Part B of Schedule 1 to this Deed.





- 1.2 References to Clauses and to Schedules are to the clauses of and the schedules to this Deed.
- 1.3 Headings are inserted for convenience only and shall not affect the construction of this Deed.
- 1.4 References to persons shall be deemed to include natural persons, companies and other bodies corporate, unincorporated associations, partnerships, firms and government bodies, governments, states and any other organisations (whether or not in each case having separate legal personality).
- 1.5 The singular shall be deemed to include the plural and vice versa.
- 1.6 This Deed shall be binding on, and enure to the benefit of, the parties to this Deed and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.
- 1.7 In this Deed words preceded by "including" or other similar phrases shall not be limited by such words or phrases and shall be deemed to be without limitation.
- 1.8 A reference to a statute or statutory provision is a reference to it as it is in force as at the date of this Deed. A reference to a statute or statutory provision shall include all subordinate legislation made as at the date of this Deed under that statute or statutory provision.
2. **Assignment and transfer**
  - 2.1 To the maximum extent permissible under applicable law, with effect from the Effective Date and pursuant to the Court Order, Wargaming World hereby transfers and assigns to Wargaming.Net absolutely, solely and exclusively, with full title guarantee and free from Encumbrances, to the extent such transfer and assignment has not already taken place by operation of law pursuant to the Court Order, all its right, title and interest in and to the Wargaming.Net Trade Marks, in each case for the whole legal term of protection of such rights, including any renewals, reversions, extensions or revivals, and together with all related rights and powers arising or accrued, including:
    - 2.1.1 the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Wargaming.Net Trade Marks;
    - 2.1.2 all goodwill, statutory, common law and equivalent rights and all other Intellectual Property Rights around the world attaching to, or subsisting in, the Wargaming.Net Trade Marks and that part of Wargaming World's business that relates to the goods and/or services in respect of which the Wargaming.Net Trade Marks are registered or used; and
    - 2.1.3 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and to obtain relief (and to retain any and all damages, account of profits, disgorgement, or other financial sums recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Wargaming.Net Trade Marks whether occurring at any time before, on, or after the date of this Deed.
  - 2.2 Wargaming World further hereby transfers ownership and control of the Wargaming.Net Domain Names to Wargaming.Net, including all its legal and beneficial interest under their respective registration agreements with their respective registrars.





3. **Further assurance**

3.1 Wargaming World shall, and shall use best endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform such acts as may reasonably be required for the purpose of giving effect to Clause 2.1, including:

3.1.1 registration of Wargaming.Net as proprietor, registrant or applicant (as applicable) of the Wargaming.Net Trade Marks, including signature of any local assignment documents, powers of attorney, office forms, office notices, certificates, declarations and application documents; and

3.1.2 assisting Wargaming.Net in obtaining, defending and enforcing the Wargaming.Net Trade Marks, and assisting with any other proceedings which may be brought by or against Wargaming.Net against or by any third party relating to the Wargaming.Net Trade Marks.

3.2 Wargaming World shall complete all legal, technical and administrative formalities necessary to transfer ownership and control of the Wargaming.Net Domain Names from it to Wargaming.Net, including:

3.2.1 provision to Wargaming.Net of all online domain name account details, including user names and passwords;

3.2.2 the selection and completion of relevant change of registrant and administrative contact functions within such domain name accounts as may be required by Wargaming.Net;

3.2.3 the provision of emails or other online notices or confirmations notifying the registrar of the domain name transfer;

3.2.4 the changing of webhosts; and

3.2.5 the execution of all documents, papers, forms and authorizations.

4. **General**

4.1 This Deed, together with any documents referred to in it, constitutes the whole agreement between the parties relating to its subject matter and supersedes and extinguishes any prior drafts of agreements relating to such subject matter.

4.2 Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Deed. Each party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this Deed.

4.3 No variation of this Deed shall be effective unless made in writing and signed by each of the parties.

4.4 If any provision or part of a provision of this Deed shall be, or be found by any authority or court of competent jurisdiction to be, invalid or unenforceable, such invalidity or unenforceability shall not affect the other provisions or parts of such provisions of this Deed, all of which shall remain in full force and effect.







- 4.5 The rights and remedies provided in this Deed are cumulative and not exclusive of any rights and remedies provided by law or otherwise.
- 4.6 No breach by any party of any provision of this Deed shall be waived or discharged except with the express written consent of the other parties.
- 4.7 No failure or delay by any party in exercising any right, power or privilege under this Deed shall operate as a waiver of that right, power or privilege and no single or partial exercise by any party of any right, power or privilege shall preclude any further exercise of that right, power or privilege or the exercise of any other right, power or privilege.
- 4.8 This Deed may be executed in one or more counterparts but shall not be effective until each party has executed at least one counterpart and each such counterpart shall constitute an original of this Deed, but all the counterparts shall together constitute the same instrument.
- 4.9 This Deed does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any terms of this Deed.
- 4.10 This Deed is drafted in the English language. The English language version of this Deed and any notice or other document provided under or in connection with this Deed, shall prevail if there is a conflict, except where the document is a constitutional, statutory or other official document.
- 4.11 This Deed and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of England.
- 4.12 Each party irrevocably agrees that the courts of England shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Deed or its subject matter or formation.

IN WITNESS WHEREOF, the parties hereto have executed this document as a deed and delivered it as of the date first written above.



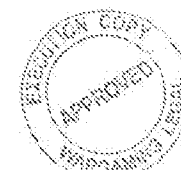
