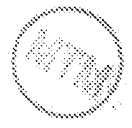

A. The name of the Company is "Red Star Traders, LLC" (Entity No. 5747450-0160).



The name of the limited liability company is RST Brands, LLC (the "Company").


