Third: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by the surviving corporation and the merging limited liability company.


Fourth: The Agreement of Merger is on file at 410 Terry Avenue N, Seattle, WA 98109, the place of business of the surviving corporation.
