TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made and entered into with effect from the 1st day of November, 2019 (the "Effective Date"), by and between **SUSTAINABLE LUXURY MAURITIUS LIMITED**, a company incorporated under the laws of Mauritius, with its registered office at c/o Venture Corporate Services (Mauritius) Limited, Level 3, Tower 1, Nexteracom Towers, Cybercity, Ebene, Plaines Wilhems, 72201 Mauritius (the "ASSIGNOR") and **SIX CONTINENTS LIMITED**, a company incorporated under the laws of England and Wales (company number 00913450), with its registered office at Broadwater Park, Denham, Buckinghamshire, UB9 5HR (the "ASSIGNEE").

WHEREAS, EACH ASSIGNOR has adopted and is the record owner of the trademarks shown in the attached Schedule A against such Assignors name (collectively, the "Marks"), being all the registered and unregistered Marks in respect of the Six Senses brand;

WHEREAS, ASSIGNEE is desirous of acquiring the Marks, together with the goodwill of the business associated with the Marks, subject to the exclusive, irrevocable, and perpetual agreements for the license of intellectual property between the Assignors and certain assignees as shown in the attached Schedule B (the "IP Licenses");

NOW, THEREFORE, for nominal value, each ASSIGNOR assigns to ASSIGNEE all right, title and interest in and to the Marks, subject to the license of the Marks under the IP Licenses, together with the goodwill of the business symbolized thereby, all common law rights to the Marks, if any, all rights of action accrued, including without limitation the right to sue and recover for past infringement of the Marks and collect the same for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, and all records and files exclusively relating to the Marks. This Assignment shall be governed by and construed in accordance with the laws of England and Wales and the parties irrevocably agree that the courts of England shall have exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Assignment. Each party submits to the jurisdiction of the English courts for all purposes relating to this Assignment.

This Assignment may be executed in counterparts, which taken together shall constitute one and the same agreement.
