WHEREAS, Cowhouse Partners and Chemex Global understood and intended that the Registrations were to be and were in fact assigned to Chemex Global as of January 1, 2018, and the parties have acted in accordance with that belief since that date; and

WHEREAS, Cowhouse Partners and Chemex Global wish to clarify and confirm that the Registrations were assigned to Chemex Global on January 1, 2018.

Assignor does hereby sell, assign and transfer to Assignee, and its successors and assigns, the entire right, title and interest in the Registrations, together with the goodwill symbolized by said Registrations, as well as any rights Assignor may have acquired by virtue of its use of the Registrations, including any and all legal and equitable causes of action for any past, present or future infringement or unauthorized use of said Registrations and the right to recover for all damages for such infringements, such Registrations to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made;


2. Assignor covenants that it will cooperate with the Assignee and perform all such other acts and things as Assignee may reasonably require to more effectively accomplish this assignment, transfer, and recordation;

3. This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding on Assignor and its successors and assigns.
