ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS ("Assignment") is made and entered into as of this 8TH day of April 2020, ("Transfer Date"), by INDIANA BEACH HOLDINGS LLC, an Indiana limited liability company ("Assignee"), and APEX PARKS GROUP, LLC, a Delaware limited liability company ("Assignor").

Preliminary Statement:

Assignor desires to assign to Assignee its interest in the trademarks "Indiana Beach" and "Indiana Beach Amusement Resort" which are used to identify entertainment services in the nature of a water park and amusement park, including the goodwill of the business symbolized by said trademarks, along with the associated U.S. Trademark Registrations numbered 5098521 ("Indiana Beach Amusement Resort") and 5001993 ("Indiana Beach"), copies of which are attached as Exhibit A.

In consideration of the mutual covenants contained in this Assignment, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. ASSIGNMENT OF TRADEMARKS. As of the Transfer Date, Assignor hereby assigns and transfers all of its right, title, claim and interest in, to and under the Indiana Beach trademark and the Indiana Beach Amusement Resort trademark, including the goodwill of the business symbolized by said trademarks, to Assignee, and its successors and assigns.
2. ACCEPTANCE OF ASSIGNMENT. Assignee as of the Transfer Date hereby accepts the foregoing assignment of the Indiana Beach trademark and the Indiana Beach Amusement Resort trademark and assumes all of the Assignor's rights obligations thereunder which arise or relate to the period of time after the Transfer Date.
3. BINDING EFFECT. This Assignment will be binding on and inure to the benefit of the parties herein, their heirs, executors, administrators, successors-in-interest and assigns.
4. GOVERNING LAW. This Assignment will be governed by and construed in accordance with the internal laws of the State of Delaware without regard to principles of conflicts of laws.
