## TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (the "Agreement") is made as of May 8, 2020 (the "Effective Date"), by and among CMBG ADVISORS, INC., a California corporation, in its sole and limited capacity as assignee for the benefit of creditors of C&F Foods, Inc., and its subsidiaries ("Seller"), and Trinidad/Benham Corp. ("Buyer").

**WHEREAS**, pursuant to the assignment for benefit of creditor laws of the State of California, C&F Foods, Inc. and its subsidiaries (collectively, "Assignor"), designated Seller to act as the assignee for the benefit of creditors of Assignor (the "General Assignment");

**WHEREAS**, pursuant to terms of the General Assignment, Assignor conveyed, assigned, transferred, delivered and set over to Seller all of Assignors' right, title and interest in and to any and all trademarks and trade names, together with the goodwill of the business associated with and symbolized by same, held by Assignor immediately prior to the consummation of the General Assignment, together with all common law rights therein and the right to sue for past infringement of any and all of said trademarks, including the marks set forth in Schedule A (the "Marks").

**WHEREAS**, by resolution of the board of directors of Seller, on May 1, 2020, Seller is transferring ownership of all of its right, title and interest in and to certain of assets of the Assignor estate to Trinidad/Benham Corp., a Colorado corporation ("Buyer"), as set forth in that certain *Asset Purchase Agreement* entered into by and between Seller and Buyer, dated as of May 1, 2020 (the "APA");

**WHEREAS**, Seller and Buyer desire to memorialize the transfer of the Assignor estate's trademarks and related rights to Buyer.

**NOW, THEREFORE, BE IT KNOWN**, that Seller hereby conveys, assigns, transfers, delivers and sets over to Buyer all of Sellers' right, title and interest in and to the Marks, together with the goodwill of the business associated with and symbolized by same, all common law rights therein and the right to sue for past infringement of any and all of said trademarks. Seller expressly disclaims representations or warranties whatsoever with respect to such assets, including, without limitation, any representations or warranties with respect to title, and transfers title to the Marks "as is where is." The transfer, sale and assignment of such Marks is pursuant to the APA, and thus, subject to all of the terms and conditions set forth therein.

Seller hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, or with respect to any foreign trademarks or service marks or applications or registrations for such Marks the foreign equivalent as the case may be, to record Buyer as owner of the Marks and to issue any and all registrations, including renewals thereof, to Buyer, its successors, assigns, nominees or other legal representatives.

All rights and any income, royalties or payments otherwise due or payable to Seller with respect to any Marks as of the date hereof or thereafter, will be held and enjoyed by Buyer, its successors, executors and permitted assigns.

All exhibits referenced herein are incorporated herein and expressly made a part of this agreement as though completely set forth herein.

This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which shall constitute the same agreement. This agreement and any signed agreement entered into in connection herewith or contemplated hereby, and any amendments hereto or thereto, to the extent signed and delivered by facsimile or .pdf (or equivalent electronic transmission), shall be treated in all manner and respects as an original contract and shall be considered to have the same binding legal effects as if it were the original signed version thereof delivered in person.
