RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of May 10, 2020 is made by FIFTH THIRD BANK, NATIONAL ASSOCIATION (for itself and as agent for each affiliate of Fifth Third Bancorp; collectively, "Secured Party"), and is as follows:

WHEREAS, KELME USA, INC., a Florida corporation ("Debtor"), and Secured Party are parties to that certain Security Agreement, dated as of December 2, 2003, which was recorded with the United States Patent and Trademark Office on April 20, 2007 in its records at Reel 3527, Frame 0489 (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Secured Party, among other things, a continuing and unconditional security interest in Debtor's right, title and interest in and to: (a) all of Debtor's general intangibles, which include, among other things, the trademarks listed on Schedule I attached hereto and made a part hereof (the "Trademarks"), (b) all obligations or indebtedness owed to Debtor relating to the Trademarks, (c) all rights of Debtor to receive any payments in money or in kind relating to the Trademarks, (d) all cash or non-cash proceeds relating to the Trademarks, (e) all guaranties of the foregoing and security therefor, and (f) all of the right, title and interest of Debtor in and with respect to the goods, services, or other property that gave rise to or secures any of the foregoing and insurance policies and proceeds relating thereto (all of the foregoing being, collectively, the "Trademark Collateral");

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral, including each mark and registration listed on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest in, and all other rights in, to and under the Trademark Collateral, including each mark and registration listed on Schedule I attached hereto.
