AMENDMENT TO AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

(SENIOR FACILITY)

This amendment (this "*Amendment*") amends that certain Amended and Restated Intellectual Property Security Agreement, dated as of May 10, 2018, by and between **SILICON VALLEY BANK**, a California corporation (the "*Bank*"), and **KENSHOO LTD.**, a company organized under the laws of the State of Israel (the "*Grantor*") (as may be amended from time to time, the "*IP Security Agreement*"). Capitalized terms used herein but not otherwise defined shall have the meaning given to such terms in the IP Security Agreement.

RECITALS

WHEREAS, the Grantor, Bank, **KENSHOO, INC.**, a Delaware corporation, and **KENSHOO (UK) LIMITED**, a company registered under the laws of England and Wales, are parties to that certain Amended and Restated Senior Loan and Security Agreement dated as of May 10, 2018 (as may be amended from time to time, the "*Loan Agreement*") pursuant to which the Bank made loans to the Grantor which are secured by the collateral described in the IP Security Agreement; and

WHEREAS, the Grantor and the Bank now desire to amend the IP Security Agreement to, among other things, grant a security interest in additional intellectual property acquired since the effective date of the Loan Agreement.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and the mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Exhibit B (Patents) to the IP Security Agreement is hereby replaced in its entirety with Exhibit B (Patents) attached hereto.
2. Exhibit C (Trademarks) to the IP Security Agreement is hereby replaced in its entirety with Exhibit C (Trademarks) attached hereto.
3. This Amendment shall be governed by and construed under the laws of the United States and the Commonwealth of Massachusetts in all respects as such laws are applied to agreements among Massachusetts residents entered into and performed entirely within Massachusetts.
4. This Amendment shall be binding upon the Grantor and its successors and assigns and inure to the benefit of the Bank and its successors and assigns.
5. This Amendment, together with the IP Security Agreement, constitute the full and entire understanding and agreement between the parties with regard to the subjects hereof and thereof as a complete and final integration thereof.
6. Except as specifically otherwise modified herein, the IP Security Agreement as previously executed remains in full force and effect.

7. This Amendment may be executed in one or more counterparts (including, without limitation, facsimile and electronic signature), each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
8. The parties to this Amendment shall execute and deliver such further documents and instruments and shall take such other actions as may be reasonably required or appropriate to evidence or carry out the intent and purposes of this Amendment or to show the ability to carry out the intent and purposes of this Amendment.



