**NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT AND ASSIGNMENT OF  
TRADEMARKS**

This Nunc Pro Tunc Trademark Assignment Agreement and Assignment of Trademarks (“Agreement and Assignment”) by and between MANSCAPED (composed of TRANCORP, INC., a Nevada Corporation, and ATLANTICXING, LLC, a California Limited Liability Company), a partnership organized under the laws of California, having a business address of 3394 Carmel Mountain Road, Suite 140, San Diego, California, 92121 (“Assignor”), and Manscaped, LLC, a Limited Liability Company organized under the laws of California, have a business address of 3394 Carmel Mountain Road, Suite 140, San Diego, California, 92121 (“Assignee”), is entered into as of this 24 day of April, 2020, nunc pro tunc as of December 31, 2018 (“Effective Date”).

A. WHEREAS, Assignor owns the entire right, title, and interest in and to certain U.S. and foreign trademarks, both registered and unregistered, and applications for trademark registrations filed with the United States Trademark Office, as listed in attached Exhibit A (collectively the “Marks”).

B. WHEREAS Assignor and Assignee entered into that certain Contribution Agreement as of the Effective Date, including with regard to the Marks.

C. WHEREAS Assignee acquired all of Assignor’s right, title, and interest in and to the Marks together with all the goodwill of the business symbolized thereby and the underlying business to which the Marks pertain, and Assignor assigned all such right, title, and interest in and to the Marks to Assignee, nunc pro tunc as of December 31, 2018, and the parties desire to memorialize the assignment of the Marks, upon the terms and conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby conclusively acknowledged, the parties agree as follows:

1. Assignor hereby conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor’s right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, the underlying business to which the Marks pertain, and in and to all income, royalties, damages, claims, and payments now or hereafter due or payable with respect thereto, and in and to all causes of action, including but not limited the right to sue for past infringement, either in law or in equity for past, present, or future infringement, based on the Marks, and in and to all rights corresponding to the foregoing throughout the world.
