(hereinafter called "the said Trade Marks")


(2) The Assignor has agreed with the Assignee for the sale and transfer to the

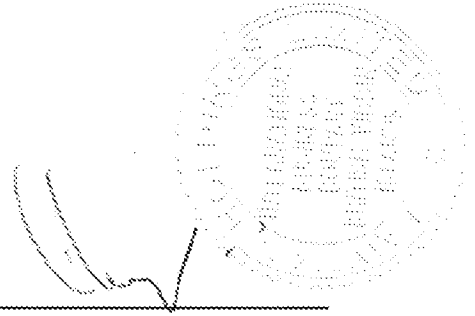

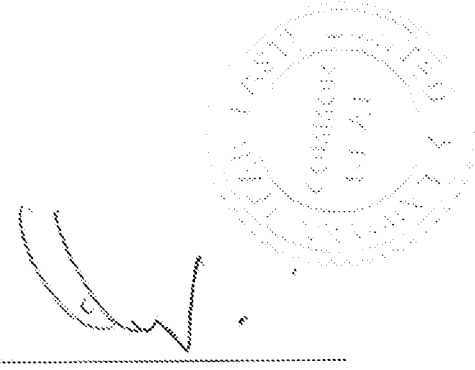
