TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Frontier Spinning Mills, Inc., a Delaware corporation (“Grantor”), is the owner of record of the trademarks listed on the attached Exhibit A, issued by the United States Patent and Trademark Office (the “Trademarks”); and

WHEREAS, the Grantor entered into that certain Amended and Restated Revolving Credit and Security Agreement dated December 19, 2013 by and among Grantor, Frontier Spinning Mills Holding Corp., a Delaware corporation, the lenders from time to time party thereto (the “Lenders”), and PNC Bank, National Association, in its capacity as agent for the Lenders (together with its successors and assigns in such capacity, “Agent”); and

WHEREAS, pursuant to the Credit Agreement, Grantor entered into a Trademark Security Agreement, dated as of December 19, 2013 (the “Trademark Security Agreement”) pursuant to which Grantor granted PNC (PNC, in such capacity, “Grantee”), for the benefits of the Lenders, a security interest in the Trademarks attached as Exhibit A; and

WHEREAS, Grantee now desires to release its security interest in the Trademarks and terminate the Trademark Security Agreement; and


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged as of this 31st day of December, 2019, Grantee hereby:

1. Releases any and all liens, security interests, rights, title and interest of Grantee pursuant to the Trademark Security Agreement in the trademarks and applications more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and
2. Authorizes and request the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
