**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK, dated as of May 27, 2020 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) for the Secured Parties referenced in the Security Agreement defined below, in favor of SPX Flow, Inc., a Delaware corporation (“Grantor”).

WHEREAS, pursuant to that certain Security Agreement dated as of July 11, 2016 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing; and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks (“Notice”), which was recorded with the United States Patent and Trademark Office (“USPTO”) on July 14, 2016 at Reel 5834 Frame 0332.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, solely the Trademark listed on Schedule A attached hereto (and any and all Proceeds thereof), granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


SECTION 3. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
