**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 19, 2019 (“Release”), is made by BSP Agency LLC, a Delaware limited liability company, as successor in interest to Triangle Capital Corporation as Agent (“Agent”), in favor of **SCUF GAMING INTERNATIONAL LLC**, a Georgia limited liability company (“Grantor”), pursuant to that certain Security and Pledge Agreement dated December 7, 2016 (as amended, modified, restated, renewed, replaced or supplemented from time to time, the “Agreement”);

WHEREAS, in connection with the Agreement, Grantor executed and delivered a certain Grant of Security Interest in Trademarks, which is recorded at the United States Patent and Trademark Office (“USPTO”) on December 12, 2016 at Reel 5946/Frame 0049 and Reel 5956/Frame 0122 (“Notices”), whereby Grantor granted to Agent, a continuing security interest in and continuing lien upon the trademark registrations and trademark applications on Schedule I attached hereto (“Trademarks”);

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Agreement.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby irrevocably terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Trademarks granted pursuant to the Agreement and the Notices, and acknowledges that such termination is in accordance with the terms of the Agreement. The Agent hereby authorizes the Grantor, and any of their designees, to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the security interest in the Trademarks contemplated hereby.
