
## Notarial Certificate

I, the undersigned Dr. Armin Hauschild, German Notary duly admitted and sworn in with official residence at Düsseldorf, herewith certify and confirm upon today's inspection of the historical and chronological extracts of the Commercial Register at the Local Court at Iserlohn under No. HRA 2031 and HRB 5726, that:

- Friedrich Grohe AG & Co. KG was previously a "Kommanditgesellschaft" (limited partnership) with its registered office in Hemer, entered in the Commercial Register at Iserlohn under No. HRA 2031.
- The name of the company was changed to:
  - Grohe Water Technology AG & Co. KG through its registration in the Commercial Register on 28 August 2003,
  - Grohe Water Technology GmbH & Co. KG through its registration in the Commercial Register on 10 November 2004,
  - Grohe Water Technology AG & Co. KG through its registration in the Commercial Register on 8 February 2005.
- Due to merger („Verschmelzung“) dated 24 February 2005 the assets of Grohe Water Technology AG & Co. KG were transferred to Grohe AG, by operation law. The merger entered into effect upon its registration in the Commercial Register at Iserlohn under No. HRB 5726 on 21 February 2006.
- The address of the company Grohe AG with seat at Hemer was changed into Feldmühleplatz 15, 40545 Düsseldorf. The change of the address became effective upon its registration in the Commercial Register on 18 March 2009.
- Thereby the company Grohe Water Technology AG & Co. KG with domicile at Hemer was officially cancelled. Consequently, Grohe AG is the legal successor of Friedrich Grohe AG & Co. KG.
