Section 1060), and for all foreign countries, including the right to renew or extend any registration included in the Assigned Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Assigned Trademarks, and any priority right that may arise from the Assigned Trademarks.

Governing law: The formation, validity, construction and performance of this deed will be governed by and construed in accordance with the laws of the United States. The parties irrevocably agree that the courts of the United States will have non-exclusive jurisdiction to hear and determine all disputes under or in connection with this deed.


