## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This Intellectual Property Security Agreement Release (this "Release") is made 28 May 2020, by Coöperatieve Rabobank U.A., as security agent (the "Security Agent"), for the benefit of Viju, Inc. (now known as Kinly Inc., the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the IP Security Agreement (as defined below).

**WHEREAS**, pursuant to an Intellectual Property Security Agreement, dated as of November 2, 2017 (the "IP Security Agreement"), between the Grantor and the Security Agent, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office (the "Office") on November 1, 2017, at Reel/Frame 6195/0012, the Grantor has granted a security interest in its right, title and interest in and to the intellectual property listed in Annex 1 hereto (the "Intellectual Property") to the Security Agent; and

**WHEREAS**, in connection with the discharge of all liabilities and obligations, the Security Agent has agreed to release the security interests created under the IP Security Agreement.

**NOW, THEREFORE**, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby agrees as follows:

1. Termination and Release.

The Security Agent hereby terminates, cancels, discharges and fully releases its lien on and security interests in and to the Intellectual Property created by the IP Security Agreement as of the date first written above. If and to the extent the Security Agent has acquired any right, title or interest in or to any of the Intellectual Property, it hereby assigns and transfers such right title or interest to the Grantor.

The Security Agent hereby authorizes and requests that the United States Patent and Trademark Office record this Release.

2. Miscellaneous.

(a) THIS RELEASE SHALL FOR ALL PURPOSES BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (WITHOUT REGARD TO THE CONFLICT OF LAW PRINCIPLES THEREOF TO THE EXTENT THAT THE SAME WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION).

(b) This Release may be executed in one or more counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument.
