**TERMINATION AND RELEASE OF
PATENT AND TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Patent and Trademark Security Agreement (“Release”) is made as of May 28, 2020, by **CRG SERVICING LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) in favor of CORREVIO INTERNATIONAL SARL, a Switzerland corporation with an address at Place Des Alpes 4, Geneva, Switzerland 1201 (successor in interest to CORREVIO LLC) (the “Grantor”).

W I T N E S S E T H:

WHEREAS, Correvio LLC entered into a certain patent and trademark security agreement dated June 13, 2016 (the “IP Security Agreement”) with Administrative Agent, notice of which was recorded on June 20, 2016 at the United States Patent and Trademark Office at Reel 5818, Frame 0047.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor has granted to the Administrative Agent, under the terms of the IP Security Agreement, a security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of such Grantor’s right, title and interest in, to and under the following (collectively, the “IP Collateral”):

- (i) all patents and patent applications, in each case whether now owned by Grantor or hereafter acquired and whether now existing or hereafter coming into existence, including without limitation those listed on Schedule A hereto, and all related patents and applications thereto, including all reissuances, continuations, continuations-in-part, revisions, extensions, re-examinations thereof, any patents and patent applications claiming priority to said patents and patent applications or from which said patents and patent applications claim priority, and pending applications associated therewith;
- (ii) and (ii) all of the trademarks, whether now owned or at any time hereafter acquired, of Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office, including the trademarks listed on Schedule A hereto, and all registrations and pending applications associated therewith (excluding any application for registration of a trademark filed on an intent-to-use basis solely to the extent that the grant of a security interest in any such trademark application would materially adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application).

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Secured Parties, hereby releases, terminates and discharges any and all of its interest in the IP Collateral of Grantor.
