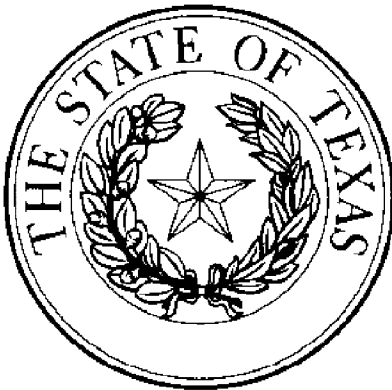

CERTIFICATE OF CONVERSION

(a Texas limited liability company)

Pursuant to the provisions of Sections 10.154 and 10.155 of the Texas Business Organizations Code, as amended from time to time (the "TBOC"), the undersigned converting entity certifies the following Certificate of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the TBOC.

FIRST: The name of the converting entity is Silver Eagle Distributors, L.P. (the "Converting Entity"). The Converting Entity is a Texas limited partnership organized pursuant to the TBOC. The Converting Entity was formed as a Texas corporation on April 26, 1988 and converted to a Texas limited partnership on July 12, 1999. The filing number of the Converting Entity is 12248910.

SECOND: The name of the converted entity is Silver Eagle Beverages, LLC (the "Converted Entity"). The Converted Entity will be organized as a Texas limited liability company pursuant to the TBOC. A copy of the certificate of formation of the Converted Entity is attached as Exhibit A to this document.

THIRD: A Plan of Conversion (the "Plan of Conversion") was duly authorized and approved by all action required by the laws of the State of Texas, including the TBOC, and by the Converting Entity's governing documents.

FOURTH: The address of the principal place of business of the Converting Entity is 4609 New Highway 90 West, San Antonio, Texas 78237. An executed Plan of Conversion is on file at such address. The address of the principal place of business of the Converted Entity will be 4609 New Highway 90 West, San Antonio, Texas 78237. An executed Plan of Conversion will be on file, from and after the conversion, at such address.

FIFTH: A copy of the Plan of Conversion will be furnished by the Converting Entity, prior to the conversion, or the Converted Entity, from and after the conversion, on written request and without cost, to any partner of the Converting Entity or any member of the Converted Entity.

SIXTH: In lieu of providing a tax certificate, the Converted Entity will be liable for the payment of any franchise taxes.

SEVENTH: This document becomes effective when it is accepted and filed by the Secretary of State of the State of Texas.

**CERTIFICATE OF FORMATION
OF
SILVER EAGLE BEVERAGES, LLC**

The undersigned person, acting as the organizer of a limited liability company under the Texas Limited Liability Company Act, part of the Texas Business Organizations Code, as amended from time to time (the “TBOC”), does hereby submit the following Certificate of Formation for such limited liability company:

1. The filing entity being formed is a limited liability company. The name of the entity is Silver Eagle Beverages, LLC.
2. The filing entity was originally formed as a corporation named “Silver Eagle Distributors, Inc.” in the State of Texas on April 26, 1988, whose filing number was 107529200 and principal place of business was 7777 Washington Ave., Houston, Texas 77007, which corporation was converted to a limited partnership named “Silver Eagle Distributors, L.P.” in the State of Texas on July 12, 1999, whose filing number was 12248910 and principal place of business was 4609 New Highway 90 West, San Antonio, Texas 78237 (the “Converting Entity”). The Converting Entity was converted to a limited liability company named “Silver Eagle Beverages, LLC” pursuant to a Plan of Conversion that was duly authorized and approved by all action required by the laws of the State of Texas, including the TBOC, and by the Converting Entity’s governing documents.
3. The purpose for which the company is formed is for the transaction of any and all lawful purposes for which a limited liability company may be organized under the TBOC.


