TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made and dated as of May 20 2020 (the "Effective Date"), by and between Lucky Cat Ramen, a Tennessee limited liability company, with an address 129 North Belvedere Blvd, Apt. 8, Memphis, TN 38104 ("Assignor"), to Walden-Hays, Inc., a New York corporation, with an address of PO Box 1071 New York, NY 10276 ("Assignee").

WHEREAS, Assignor is the sole and exclusive owner the federal trademark LUCKY CAT RAMEN, as set forth on Exhibit I hereto as well as common law rights in and to the trademarks LUCKY CAT RAMEN and LUCKY CAT in connection with restaurant services both of which have been in use since at least as early as December 2016 (hereinafter, collectively referred to as the "Marks");

WHEREAS, Assignee desires to acquire from Assignor, and Assignor agrees to transfer and assign to Assignee, all of Assignor's right, title and interest in and to the Marks, together with the goodwill of the business connected with the use of and symbolized by the Marks;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee, intending to be legally bound, covenant and agree as follows:

Assignor hereby sells, transfers and assigns to Assignee, as fully and entirely as the same would have been held and enjoyed by Assignor if this transfer and assignment had not been made, and Assignee hereby accepts the transfer and assignment of (i) all of Assignor's right, title and interest in and to the Marks, together with the goodwill symbolized by the Marks, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors and assigns, and (ii) all rights of Assignor to bring an action, whether at law or in equity, against any third party for infringement or other misuse of the Marks, including the right to bring an action for past, present and future infringement, dilution, unfair competition, or other misappropriation or misuse, and all rights to recover damages, profits, attorneys' fees, and injunctive relief for infringement, dilution, unfair competition, or other misappropriation or misuse.
