RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this “**Release**”) is made effective as of March 10, 2020 (the “**Effective Date**”), by and from PNC Bank, National Association (“**Agent**”) to Avenue Stores, LLC (“**Grantor**”).

WHEREAS, Agent and Grantor are parties to that certain Intellectual Property Security Agreement dated April 12, 2019 (the “**Security Agreement**”), pursuant to which Grantor granted Agent a security interest in the trademarks set forth in Exhibit A hereto (the “**Trademarks**”);

WHEREAS, the Security Agreement has been recorded in the United States Patent and Trademark Office at Reel 6620, Frame 0449; and

WHEREAS, on August 16, 2019, Grantor and certain of its affiliates filed petitions for relief under chapter 11 of Title 11 of the United States Code in the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”), commencing Case No. 19-11842-LSS;

WHEREAS, on October 7, 2019, the Bankruptcy Court entered the Order Authorizing and Approving (I) the Sale of E-Commerce Business Assets Free and Clear of Liens, Claims, Rights, Encumbrances, and Other Interests; (II) the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases; and (III) Related Relief [Docket No. 339], pursuant to which the Bankruptcy Court approved the sale of, among other things, the Trademarks, free and clear of all liens, claims, encumbrances, and other interests;

WHEREAS, Agent wishes to evidence the release of its security interest in the Trademarks, and retransfer and reassign to Grantor, without recourse, all of its right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. Release of Security Interest. Agent (for itself and on behalf of the Secured Parties) hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademarks and any rights therein, including any goodwill of the business symbolized by the foregoing, all rights to sue for past, present, and future infringements thereof, and any income, royalties, and proceedings resulting therefrom, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
3. Authorization to Record. Agent authorizes Grantor to have this Release or any other similar release filed with the United States Patent and Trademark Office.
4. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
